ENROLLMENT STIPULATIONS AND REQUIREMENTS: A \$35 Non-refundable annual mission fee will be added to your tuition. This annual fee covers the cost of ACT community events. All fees and tuition is non-refundable. Our No Refund and No Credit policy is in effect at all times. Annual contracts must be signed and returned within ten working days from when it is issued. Due dates of balance payments are noted in the annual contract. Deposit must accompany this application. Failure to pay tuition on schedule forfeits a child's placement in the program. Credit card payments incur a credit card processing fee. Medical forms, and all DOH requirements, as well as birth certificates are required for Nursery and Preschool. Full Time Preschoolers need to be fully potty trained by the start date of Preschool. We reserve the right to cancel or change a class given its registration. You will be promptly notified and you will receive a full refund in the event of a class cancellation. Two make up classes are allowed for one-to-one toddler classes. Full payment is due at the time of registration for one to one classes.
