PAYMENT AND FEES
Applications for Financial Aid are due by April 1, 2024.
Registration fee must be submitted along with this application and will be applied towards your camper's tuition.
In event a space is not available, the fee will be returned in full.
Full payment for all sessions must be received by June 20th (July Camp) or July 25th (Adventure Camp).
If you are applying to camp after these payment deadlines, full payment is due with the application.
REFUND POLICY
Refunds will not be granted after March 1, 2024.
Financial Aid applicants who do not receive any aid will be refunded their registration fee if they choose not to enroll.
Credits or refunds will not be offered if your camper is absent regardless of the amount of days missed.
PROGRAM CHANGES AND EXPULSION
ACT reserves the right to change, cancel or postpone activities without notice when necessary.
ACT reserves the right to remove a camper from a group or from the program for reasons which leadership deem good and sufficient.
